#### **FY24 Results**

1. ALLHC registered consolidated revenues of P5.2 billion (+48%) and net income of P701 million (+10%).

 Industrial lot sales increased mainly driven by Laguindingan Technopark sales and higher completion rates, while revenues from leasing businesses posted growth from solid performance across warehouse, cold storage, and commercial assets.

3. Balance sheet stands with a net debt-to-equity ratio of 0.92:1.
